### The Role:

Reporting to the Chief Building Inspector, the Building Inspector provides services such as reviewing, assessing and enforcing compliance with building by-laws, codes, statutes and regulations pertaining to building safety and property standards of the BC Building Code. The incumbent examines permits, plans and specifications for all buildings to ensure compliance with applicable planning, zoning, and environmental issues within the TNRD and province.

### Our Ideal Candidate:

The ideal candidate will have or be working towards BOABC certification with applicable experience and or an equivalent combination of education and experience. You will have sound knowledge of:

- Residential construction plans for compliance with regulations and permit issues
- Non-compliant construction and determining appropriate action
- Inspection reports to ensure full completion
- BC Building Code and Plumbing Code

It is anticipated that this vacancy will be for a minimum of 4 months. The rate of pay is based upon level of certification and experience:
